

DELEGATION OF AUTHORITY — POWER OF ATTORNEY

For the Opening and Operation of an Airwallex Account

1. Parties and Corporate Authority

We, the undersigned, being duly authorised signatories of the company identified below (the "Company"), hereby issue this Delegation of Authority and Power of Attorney (this "Power of Attorney") in favour of the individuals named in Section 2 below (each, a "Delegated Individual" and collectively, the "Delegated Individuals").

Each of the undersigned authorised signatories hereby confirms that he or she is duly authorised to act on behalf of the Company and to execute this Power of Attorney pursuant to the Company's Board Resolution Regarding Authorised Signatories, a copy of which is attached hereto or has been previously provided to Airwallex (Israel) Ltd. ("Airwallex").

2. Delegated Individuals

The Company hereby designates the following individuals as Delegated Individuals under this Power of Attorney:

The authority granted to the Delegated Individuals under this Power of Attorney is personal and non-transferable. No Delegated Individual may further delegate, assign, or sub-delegate any of the powers or authority conferred by this Power of Attorney to any other person or entity.

3. Scope of Delegated Authority

Each Delegated Individual is hereby authorised to perform the following actions on behalf of the Company in connection with the Company's account(s) with Airwallex (the "Account"):

- (a) Opening and submitting an application for an Airwallex account on behalf of the Company;
- (b) Executing and approving payments, transfers, or other financial transactions through the Account;
- (c) Managing payment approval workflows within the Account;
- (d) Issuing, activating, deactivating, and otherwise managing company cards linked to the Account;
- (e) Adding, removing, or managing payees and beneficiaries associated with the Account;
- (f) Opening additional accounts, including global accounts, on behalf of the Company;
- (g) Managing integrations, operational settings, and any other day-to-day administrative functions related to the Account.

4. Limitations of Authority

Notwithstanding the foregoing, the authority delegated under this Power of Attorney expressly excludes, and no Delegated Individual shall have the power to undertake, any of the following actions:

- (a) Appointing or removing authorised signatories of the Company;
- (b) Transferring ownership of the Account or any interest therein;
- (c) Modifying the Company's authorised signatory structure or amending the Company's Board Resolution Regarding Authorised Signatories.

The foregoing actions shall remain exclusively reserved for the Company's authorised signatories acting in accordance with the Company's constitutional documents and applicable Board Resolution.

5. Reliance by Airwallex

The Company hereby confirms and agrees that:

- (a) Airwallex may rely, without further inquiry, on any instruction, request, or communication given by a Delegated Individual in connection with the Account, as if such instruction had been given directly by the Company's authorised signatories;
- (b) Airwallex shall not be required to verify or inquire into the internal corporate authority of any Delegated Individual beyond this Power of Attorney;
- (c) All instructions, requests, and communications provided by a Delegated Individual acting within the scope of the authority granted herein shall be binding upon the Company, and the Company shall bear full responsibility for any and all actions taken by Airwallex in reliance upon such instructions.

6. Revocation and Duration

This Power of Attorney shall remain in full force and effect until revoked in writing by the Company's authorised signatories. Any such revocation shall be delivered to Airwallex in writing and shall take effect upon actual receipt by Airwallex. Airwallex shall be entitled to rely on the authority granted herein until it receives written notice of revocation.

7. Governing Law

This Power of Attorney shall be governed by and construed in accordance with the laws of the State of Israel.

8. Representations and Warranties

The undersigned authorised signatories hereby represent and warrant that:

- (a) They have the requisite power and authority to execute this Power of Attorney on behalf of the Company;
- (b) The execution and delivery of this Power of Attorney has been duly authorised by all necessary corporate action, including under the Company's Board Resolution Regarding Authorised Signatories;
- (c) This Power of Attorney does not conflict with any provision of the Company's constitutional documents or any other agreement or obligation to which the Company is a party or by which it is bound.
